Show Organiser Information

Sunshine Tour Championships held at The All England Jumping Course, Hickstead,
from Thursday 12th – Sunday 15th September 2024

Dressage, Show Jumping & Showing qualifiers are held from 1st January to 31st July 2024

Eventers Challenge qualifiers are held from 1st November 2023 to 31st July 2024

Organisers MUST NOT advertise/list dates or schedules outside the qualification period as qualifiers.

Essential information

Show Organisers - ESSENTIAL TO KNOW & ACTION TO TAKE

- **ALL SHOW DATES MUST** be submitted to Sunshine Tour prior to running a qualifier event.
- **RESULTS MUST** be published **WITHIN 2 WEEKS** of each qualifying competition for competitors to use.
- **EACH PAGE OF RESULTS MUST** clearly show the venue/organiser **AND** the date **AND BOTH** the horse's and competitor's name.
- **DRESSAGE & SHOWJUMPING 1st to 3rd place qualifies.**
- **SHOWING & EVENTER'S CHALLENGE 1st to 4th place qualifies.**
- **Shows must be open to ALL.** Open to all competitors to enter without being a member or paying a membership fee.
- **You MUST NOT offer qualifiers outside of the qualification period.** Please make this **VERY CLEAR** in your schedules, especially omnibus schedules.

KEY FACTS

Key Facts for Show Organisers

- **Qualification Period:** Dressage, Show Jumping & Showing qualifiers from 1st January to 31st July 2024, Eventers Challenge qualifiers from 1st November 2023 to July 31st 2024.
- **Registered Centres/Clubs/Shows** are automatically listed on our website on a printable list that is circulated to competitors. You are given the opportunity to publicise your show dates via our Facebook page and group.
- **Qualifier classes** are listed on the website and sent to you. However, this is just for your information and to help advise competitors, it is up to the competitor to know which classes are eligible.
- You are expected to run competitions to a good standard judged according to relevant rules. We recommend British Dressage, British Showjumping, British Riding Club, Pony Club or an official show society.
- We reserve the right to withdraw registered shows who are not 'playing by the rules' or we feel that you are not upholding the standards expected, not completing the competitors' qualification process or advertising shows as qualifiers outside the qualification period.

Action Points – What Show Organisers NEED TO DO

ACTION POINTS

1. **Complete** an online application. We'll send information and resources pack via email, or post if you choose.
2. **It is compulsory to submit your show dates to Sunshine Tour.** We'll publicise the dates monthly.
3. **Promote Sunshine Tour to competitors.** Use any/all methods:
 - a. Use official wording and logos in your schedule.
 - b. An official poster at your events.
 - c. Hand out information slips- these are **not** qualification tickets for proof of results!
4. **Be clear with qualifying results** - 1st to 3rd for Show Jumping and Dressage, 1st to 4th for Showing and Eventer's Challenge. One qualifying code per qualifying result given in ALL disciplines.
5. **Help competitors verify their qualification.**

ACTION POINTS

- a. **Dressage, Show Jumping & Eventers Challenge - Publish results,** within 2 weeks of your show (one week for late July shows). Clear results can be published how you choose – at the show, website, or Facebook etc, as long as they are available for competitors to access in order to verify their qualification. They **MUST** show the venue/organiser, date, class, horse and competitor details.
- b. **Showing – EITHER publish results OR sign qualifier forms.** If you are signing forms, you **MUST** tell us who is permitted to sign and you **MUST NOT** pre-sign them and hand out without the competitor details and results filled in, this does not verify a result and leads to cheating on qualifications.
